**SPRING 2021 COVID-19 POLICIES AND PROCEDURES**

**GENERAL PROTOCOL**

1. Students are required to track symptoms and temperatures daily through the **Campus Clear App**. Students must **immediately** report any of the following by calling the Wellness Center at 419-783-2548:
  - o Positive test for COVID-19
  - o Exposure to someone who has tested positive for COVID-19 or is suspected to be positive for COVID-19
  - o Any Covid-19 symptoms noted on the Campus Clear App
2. Students **must** immediately self-isolate in their room after making a report. Failure to report a positive test, symptoms, or exposure may result in immediate campus judicial sanctions up to and including loss of housing.
3. All community members will exercise safe physical distancing (at least 6 feet) at all times.
4. Students, faculty, staff, and visitors are required to wear masks in public areas and inside all buildings. Masks will be required outdoors when social distancing cannot be maintained.
5. Students will be required to wear masks in all public areas of the residence halls. This includes lounges, kitchens, restrooms, laundry rooms, and computer labs. No more than four people are permitted in a student room at any one time.
6. Guests will not be permitted in the residence halls, except for move-in and move-out purposes. Campus visitors may meet students in non-residential public or outside areas on campus but are not permitted in residence halls at any time. This includes commuter students.
7. All students will be required to test once a week for Covid-19. This will typically take place on Wednesdays.
8. Students must follow all safety guidelines for isolation or quarantine if they test positive or are exposed.
9. All proposed College events must be evaluated to determine if they can be held safely. Events should be held virtually, outdoors, or in indoor spaces that allow social distancing. If an event cannot happen safely, it will be canceled. All Student/Club/Organization events must be pre-approved by the Office of Student Life
10. Traveling on weekends is strongly discouraged.

These policies are subject to change as additional guidance is provided from federal, state, local, and NCAA entities.

**SANCTIONS FOR VIOLATING COVID-19 POLICIES**

Sanctions will be based on the severity of the offense as well as past judicial history. Typical sanctions include:

**Masks:** 1<sup>st</sup> violation: Warning    2<sup>nd</sup> Violation: Probation    3<sup>rd</sup> Violation: Removal from Housing/Campus

**Guests:** 1<sup>st</sup> Violation: Probation    2<sup>nd</sup> Violation: Removal from Housing

**Quarantine or Isolation Violations:** 1<sup>st</sup> Violation: Probation    2<sup>nd</sup> Violation: Removal from Housing/Suspension
